



GB KIZOMBA COMPETITION 2012 Professional Category

As part of V COMPETITION INTERNATIONAL OF KIZOMBA



Participation is exclusive to couples only (1 Female and 1 Male);
Evaluation is completed through two dancing tests:

◦ **First Test**

MANDATORY THEME: IMPROVISED SEMBA PERFORMANCE

The jury will select a song for the elimination stage (**Semba**) and each couple will dance to the same Semba on that elimination

◦ **Second Test**

FREE THEME : 'KIZOMBA'

The song/mix should last no longer than 2mn

The contestants can:

1. Mix various types of kizomba (slow, fast, tarraxinha) during the 2 min that are allocated to them, or use one single song, cut after 2mins
2. During the 2 min the contestants have the possibility to :
 - a) Have 30 seconds to develop their own creativity (with a soundtrack of their choice, which must be of African rhythms)

Note: **not allowed to mix in Free Theme any Semba**, since they will have it as a mandatory theme;

- b) Have a minimum of 1.30 minutes exclusive to Kizomba

3. a) or b) consist of the 2 min total presentation.

The contestants commit to not exceed their allocated 2 minutes

GENERAL INFORMATION/REGULATIONS:

1. The soundtrack used on the second test (Free Theme) in the various eliminatory stages is the responsibility of each pair. Contestant should check with the Promoter

- of the elimination they will take part the format in which their track should be handed to the promoter.
2. Props and scenography will be permitted during the second test (FREE THEME), as far as these are placed on and removed from the stage by the contestants themselves;
 3. The costumes, make-up and hair accessories for both tests are the contestants responsibility.
 4. This is a Competition with concession of rights therefore, it is forbidden to use makes or products during each presentation or any promotional material including voice over promoting brand, artist or else and branded clothing and accessories during the Competition (i.e. while dancing).
 5. Expenses related to travelling, accommodation and meals are at the contestants full responsibility for the Qualifiers and GB Final (Only other wise stated for the GB Finalist)
 6. The GB Kizomba Competition organisation will not take responsibility over eventual loss or thefts of personal objects during the Qualifiers and GB Final.
 7. The organisation will not take responsibility in the case of eventual injury on the various Qualifiers and GB final. This is the responsibility of each contestant.
 8. The FINALIST PAIR (winning couple of the V Championship International of Kizomba in Lisbon) must be available for eventual interviews or travelling within the country until ÁfricAdança 2011 (ÁfricAdança will inform of these in advance)
 9. The pairs that get selected to go through to the GB Kizomba Competition Final cannot participate in other eliminations, even with another person as their pair.
 10. The contestants have to be over 18.
 11. In case of desistance of any couples, the Jury reserves the right (if necessary) to call another couples in replacement that has competed in one of the qualifications, having as a reference the general marks in all the qualifications.
 12. Each contestant taking part consent to provide their name and contact details to the GB Kizomba Competition organisation to be contacted should finalist drop out or for feedback purposes.
 13. Contestant who do not follow the regulation will be disqualified.
